Immediately before the disposal of shares, Exa Limited held 49,553,497 shares, representing approximately 26.84% interest in the issued share capital of Grand Banks Yachts Limited.

Exa Limited is a direct wholly-owned subsidiary of Star Cruises Terminal (China) Limited which in turn is a direct wholly-owned subsidiary of Genting Hong Kong Limited. Genting Hong Kong is a company in which Golden Hope Limited as trustee of the Golden Hope Unit Trust controls more than 20% of its voting share capital. The voting units of Golden Hope Unit Trust of which Golden Hope Limited is the trustee is ultimately owned as to 100% by Summerhill Trust Compay (Isle of Man) Limited (formerly known as First Names Trust Company (Isle of Man) Limited) as a trustee of a discretionary trust.

Lim Keong Hui is a beneficiary of the discretionary trust of which Summerhill Trust Company (Isle of Man) Limited is the trustee. Exa Limited has disposed of 49,553,497 Grand Banks Yachts Limited shares representing their entire shareholding in Grand Banks Yachts Limited. The above percentage interests are calculated based on the total number of 184,634,649 issued shares in the capital of Grand Banks Yachts Limited as at March 25, 2021.
