The voting units of Golden Hope Unit Trust of which Golden Hope Limited is the trustee is ultimately owned as to 100% by First Names Trust Company (Isle of Man) Limited as a trustee of a discretionary trust.

Tan Sri Lim Kok Thay is a beneficiary of the discretionary trust of which First Names Trust Company (Isle of Man) Limited is the trustee.

As such, Tan Sri Lim Kok Thay is deemed interested in the Grand Banks Yachts Limited shares held by Exa Limited.
